5.3. Advice for firefighters.**GENERAL INFORMATION**

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. Collect extinguishing water to prevent it from draining into the sewer system. Dispose of contaminated water used for extinction and the remains of the fire according to applicable regulations.

SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS

Normal fire fighting clothing i.e. fire kit (BS EN 469), gloves (BS EN 659) and boots (HO specification A29 and A30) in combination with self-contained open circuit positive pressure compressed air breathing apparatus (BS EN 137).

SECTION 6. Accidental release measures.**6.1. Personal precautions, protective equipment and emergency procedures.**

6.2. Environmental precautions.

The product must not penetrate into the sewer system or come into contact with surface water or ground water.

6.3. Methods and material for containment and cleaning up.

Collect the leaked product into a suitable container. Evaluate the compatibility of the container to be used, by checking section 10. Absorb the remainder with inert absorbent material.

Make sure the leakage site is well aired. Check incompatibility for container material in section 7. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

Ensure that there is an adequate earthing system for the equipment and personnel. Avoid contact with eyes and skin. Do not breathe powders, vapours or mists. Do not eat, drink or smoke during use. Wash hands after use. Avoid leakage of the product into the environment.

Store only in the original container. Store in a ventilated and dry place, far away from sources of ignition. Keep containers well sealed. Keep the product in clearly labelled containers. 8.2. Exposure controls.

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.

When choosing personal protective equipment, ask your chemical substance supplier for advice.

Personal protective equipment must be CE marked, showing that it complies with applicable standards.

Provide an emergency shower with face and eye wash station.

HAND PROTECTION

Protect hands with category III work gloves (see standard EN 374).

The following should be considered when choosing work glove material: compatibility, degradation, failure time and permeability.

The work gloves' resistance to chemical agents should be checked before use, as it can be unpredictable. The gloves' wear time depends on the duration and type of use.

SKIN PROTECTION

Wear category II professional long-sleeved overalls and safety footwear (see Directive 89/686/EEC and standard EN ISO 20344). Wash body with soap and water after removing protective clothing.

EYE PROTECTION

Wear airtight protective goggles (see standard EN 166).

RESPIRATORY PROTECTION

If the threshold value (e.g. TLV-TWA) is exceeded for the substance or one of the substances present in the product, use a mask with a type A filter whose class (1, 2 or 3) must be chosen according to the limit of use concentration. (see standard EN 14387). In the presence of gases or vapours of various kinds and/or gases or vapours containing particulate (aerosol sprays, fumes, mists, etc.) combined filters are required.

Respiratory protection devices must be used if the technical measures adopted are not suitable for restricting the worker's exposure to the threshold values considered. The protection provided by masks is in any case limited.

If the substance considered is odourless or its olfactory threshold is higher than the corresponding TLV-TWA and in the case of an emergency, wear open-circuit compressed air breathing apparatus (in compliance with standard EN 137) or external air-intake breathing apparatus (in compliance with standard EN 138). 9.2. Other information.

SECTION 10. Stability and reactivity.**10.1. Reactivity.**

There are no particular risks of reaction with other substances in normal conditions of use.

AMMONIA: corrodes aluminium, iron, zinc, copper and their alloys.

BENZYL ALCOHOL: decomposes at temperatures higher than 870 °C with possibility of explosion.

10.2. Chemical stability.

The product is stable in normal conditions of use and storage.

10.3. Possibility of hazardous reactions.

No hazardous reactions are foreseeable in normal conditions of use and storage.

AMMONIA: risk of explosion on contact with strong acids and iodine. Can react dangerously with strong bases .

POTASSIUM HYDROXIDE: attacks aluminium, tin, lead and zinc. Reacts violently with acids.

2-(2-BUTOXYETHOXY)ETHANOL: can react with oxidising agents. It forms peroxides with atmospheric oxygen. When it reacts with aluminium it can generate hydrogen. May form explosive mixtures with air.

ETHANOLAMINE: can react dangerously with: acrylonitrile, chloroepoxypropane, chlorosulphuric acid, hydrogen chloride, iron-sulphur compounds, acetic acid, acetic anhydride, mesityl oxide, nitric acid, sulphuric acid, strong mineral acids, vinyl acetate, cellulose nitrate.

BENZYL ALCOHOL: may react dangerously with: hydrobromic acid and iron in the presence of heat, oxidising agents and sulphuric acid. Risk of explosion on contact with: phosphorus trichloride.

10.4. Conditions to avoid.

None in particular. However the usual precautions used for chemical products should be respected.

POTASSIUM HYDROXIDE: naked flames and heat.

2-(2-BUTOXYETHOXY)ETHANOL: avoid contact with the air.

ETHANOLAMINE: avoid exposure to air and sources of heat.

BENZYL ALCOHOL: avoid exposure to the air, sources of heat and naked flames.

10.5. Incompatible materials.

AMMONIA: silver, lead, zinc and their salts; hydrochloric acid, nitric acid, oleum, halogens, acrolein, nitromethane and acrylic acid.

POTASSIUM HYDROXIDE: Acids, metals, some plastics and rubber, water, halogenated hydrocarbons and maleic anhydride.

2-(2-BUTOXYETHOXY)ETHANOL: oxidising substances, strong acids and alkaline metals.

ETHANOLAMINE: iron, strong acids and strong oxidising agents.

BENZYL ALCOHOL: sulphuric acid, oxidising substances and aluminium.

10.6. Hazardous decomposition products.

AMMONIA: nitric oxides.

POTASSIUM HYDROXIDE: When boiled, it develops phosphine. Above decomposition temperature toxic potassium oxide fumes may develop.

2-(2-BUTOXYETHOXY)ETHANOL: hydrogen.

ETHANOLAMINE: nitrogen oxides, carbon oxides.

SECTION 11. Toxicological information.

11.1. Information on toxicological effects.

In the absence of experimental data for the product itself, health hazards are evaluated according to the properties of the substances it contains, using the criteria specified in the applicable regulation for classification. It is therefore necessary to take into account the concentration of the individual hazardous substances indicated in section 3, to evaluate the toxicological effects of exposure to the product.

This product is corrosive and causes serious burns and vesicles on the skin, which can arise even after exposure. Burns are very stinging and painful. Upon contact with eyes, it may cause serious harm, such as cornea opacity, iris lesions, irreversible eye coloration. Possible vapours are caustic for the respiratory system and may cause pulmonary edema, whose symptoms sometimes arise only after some hours.

Exposure symptoms may include: sting, cough, asthma, laryngitis, respiratory disorders, headache, nausea and sickness.

If swallowed, it may cause mouth, throat and oesophagus burns, sickness, diarrhoea, edema, larynx swelling and, consequently, asphyxia. Perforation of the gastro-intestinal tract is also possible.

This product may cause serious ocular lesions, cornea opacity, iris lesions, irreversible eye coloration.

Acute effects: stinging eyes. Symptoms may include: rubescence, edema, pain and lachrymation.

Vapour inhalation may moderately irritate the upper respiratory tract. Contact with skin may cause slight irritation.

Ingestion may cause health problems, including stomach pain and sting, nausea and sickness.

Acute effects: vapour inhalation may irritate the lower and upper respiratory tract and cause cough and respiratory disorders. At higher concentrations it can also cause pulmonary edema. Ingestion may cause health problems, including stomach pain and sting, nausea and sickness.

2-(2-BUTOXYETHOXY)ETHANOL: can be absorbed by inhalation, ingestion and skin contact; it is irritant to the skin and especially to the eyes; spleen damage may occur. Inhalation is unlikely to occur at room temperature due to the low vapour tension of the substance.
